organizations' efforts to empower communities to influence decision makers and create urgency around changes needed to advance health equity in Georgia.

Through the Building the Field of Health Advocacy program the Foundation aims to support projects that:

- Identify emerging opportunities to advance health equity in Georgia at the systems level either locally or statewide
- Elevate community voices to educate decision-makers on health-related issues of importance to communities
- Bolster the capacity of nonprofit organizations to engage in effective advocacy efforts including research, policy development, coalition building and mobilization, community engagement, and strategic communications
- Strengthen the overall field of health advocacy

Please note that funds received via this grant program cannot be used for lobbying. Guidance on what is considered lobbying can be found in this resource from Alliance for Justice.

Funding Criteria:

The Foundation anticipates investing a total of \$1.2 million to support advocacy efforts aimed at advancing health equity in Georgia. Organizations can apply for up to \$75,000 for projects that are up to 12 months in duration. Recognizing that proposed projects may deploy a variety of strategies and approaches, proposed budgets should be appropriate for the project plan. Priority will be given to projects that incorporate partnership with other organizations and community voice, use a racial equity lens to inform their work, demonstrate an understanding of influencing systems change, and reflect prior experience in advocacy and policy work. The Foundation will seek diversity in topics proposed, geographic focus, size of the organization, and other critical factors.

Eligibility Criteria:

- ❖ Be a tax-exempt public charity as qualified by the IRS, under Sections 501(c)(3). Applicants can apply with a fiscal agent or sponsor if needed.
- Work in Georgia on behalf of Georgians.
- ❖ Align with the mission, vision and values of Healthcare Georgia Foundation.

Project funds can be requested for the following:

- Salaries/benefits for staff for project-specific activities
- Project-relatedequipment
- Other direct expenses
- Consulting fees
- Grant-related travel
- Indirect expenses (maximum of 10% of total direct costs)

Project funds cannot be used for:

- More than one application per organization
- Capital campaigns or renovations
- Activities that exclusively benefit the members of sectarian or religious organizations
- Grants or scholarships to individuals
- Event sponsorships
- Existing deficits or retroactive funding



Application Requirements:

All applications must be submitted through the Foundation's Online application system. Applicants will be prompted to upload the following documents:

Proposal Narrative:

Please provide a narrative in the form of an attachment that addresses each of the components below. The proposal narrative can be up to 6 pages and must be double-spaced with at least 11-point Arial or Times New Roman font and one-inch margins. The project plan and timeline may be presented in a table format if preferred. Information presented in a table can be single-spaced and must be at least 10-point font Arial or Times New Roman font.

- ➤ Issue of Focus: Describe the issue that will be the focus of your advocacy project, the communities and/or populations impacted by this issue, how this issue relates to health equity in Georgia, and how your organization identified this issue as a priority.
- Project Goal(s) and Anticipated Impact: Describe the major goal(s) and anticipated impact of your project. If your project is successful, what will be different? Recognizing that policy and systems change can take time, project goals may not be the same as the desired policy or systems change that is the focus of your advocacy. Briefly describe your theory of change and how your project goals will contribute to policy or systems change on your selected issue.
- Policy Environment: Provide an assessment of the policy and advocacy landscape surrounding your issue of focus and the policy or systems change you are seeking. Who are the key stakeholders and decision- makers you need to engage, and what is their current level of awareness of this issue? Describe current or potential partners and allies as well as any opposition or major challenges you anticipate.
- Project Description: Describe the project you will undertake to address your issue of focus. Include information about the proposed approach and the advocacy strategies you will use. Advocacy strategies may include some combination of coalition development and mobilization, grassroots organizing, strategic communications, policy research and dissemination, community outreach and education, policymaker or decision-maker engagement, or other advocacy strategies. The advocacy strategies you select should reflect your assessment of the policy environment (for example, if your issue of focus is not well known or understood, policy research or education may be core strategies). Explain how you will coordinate your selected advocacy strategies to help advance project goals.
- Project Plan and Timeline: For each of the advocacy strategies you have identified as part of the project description, please describe the major activities associated with each strategy. Organizations that are awarded grants will be required to submit a timeline that includes additional details about these activities upon award. Please also describe any major deliverables you propose to develop as part of this project.
- Organizational Information: Provide a summary of the experience and qualifications of your organization to undertake this project. Please include examples of relevant prior work that demonstrate your organization's capacity to carry out your project. If you believe your organization would benefit from training and technical assistance to build capacity to engage in advocacy, please reference that and incorporate those needs into your project plan. Include information about key staff that will be working on this project as well as any proposed subcontractors.

Financial Documents: Applicants will be required to provide the following financial documents:

- Current Operating Expense Budget
- > 501(C)(3) IRS Letter of Determination
- Most Recent Audited Financials or 990

To apply, all applications must be submitted using the Foundation's Online application. Set up an account or log into an existing account here.

You will be able to update your application until the deadline on **September 29, 2023** by saving it and returning to the system. To avoid delays or complications in submitting your application or uploading documents, we strongly advise that you do not wait until the deadline date to submit your completed application.
