### Healthcare Georgia Foundation: Request for Proposals for Contracted Services

Healthcare Georgia Foundation is working toward a Georgia in which all people have the opportunity to attain their fullest potential for health. We recognize that effective, lasting systems change requires advocacy that elevates the voices, stories, and experiences of Georgians. The Foundation is committed to strengthening the field of advocates and to supporting organizations' efforts to empower communities to influence decision makers and create urgency around changes needed to advance health equity in Georgia.

#### **Purpose and Goals**

Georgians currently benefit from a strong field of advocacy organizations doing this work on behalf of and in partnership with people and communities across our state. To help the Foundation realize our commitment to strengthening this field, Healthcare Georgia Foundation seeks to more thoroughly understand the current health policy landscape and the capacity of the health advocacy community in Georgia. The Foundation is seeking proposals from qualified contractors to conduct a research project that will include:

- An analysis of the current policy environment that synthesizes key data and information needed to help inform strategy for the field of health advocacy.
- An overview and categorization of the different types of organizations that comprise the field.
- Mapping of how various organizations, groups, and coalitions relate to each other, such as through participation in shared projects or issue campaigns, strategic alliances, and coalitions.
- A high-level analysis of the organizational capacity of the field of health policy and advocacy including the capacity of the field as a whole to work together toward shared goals.
- An assessment of how the field of health policy and advocacy fits into the larger landscape around health policy change in Georgia.
- Initial recommendations for strengthening the field of health advocacy.

Through this research project, the Foundation also seeks to better understand:

- How health policy and advocacy organizations are connected to local community-based organizations that provide direct services or perform community-level organizing or power-building activities.
- Current and emerging policy issues commanding the attention and focus of the field.
- How the health advocacy field has infused health and racial equity into its work.
- Factors that make advocacy campaigns successful in shaping state health policy outcomes.
- The funding environment for systems change work around health.

Once a contractor is in place, we anticipate this project will take approximately 6-9 months to complete.



### **Scope of Services:**

The Foundation is seeking a qualified contractor to work closely with our staff and a small group of partners to carry out major tasks associated with this research project including:

- Perform an environmental scan of relevant data, organizational websites, news reports, funding streams, and other publicly available information that will be used to help inform the approach to the qualitative research elements and that will provide critical context for the landscape assessment.
- Identify the set of issues (e.g. health care access, behavioral health, social determinants of health, etc) that are commanding the most interest of the advocacy community. While the major focus is on state-level work, local or community-based work is also of interest to the extent it has a policy and advocacy focus or is deeply connected to the advocacy field.
- Design, develop, carry out, and analyze the results of interviews and surveying necessary to meet the purpose and goals of the project.
- Work iteratively with the Foundation staff and identified partners to develop an appropriate
  communications strategy with organizations that are active in the field to support transparency
  regarding the goals of the research project, ensure the appropriate number and types of organizations
  are being reached through the interviews and surveys, and ensure that the project stays on track to
  meet agreed-upon timelines.
- Develop a report and presentation deck that contains the findings from the environmental scan, results from the interviews and survey, an assessment of the field based on the research conducted, and recommendations for strengthening the field of health policy and advocacy.

#### **Oualifications:**

- Working knowledge of health policy, advocacy, and the nonprofit sector in Georgia.
- Professional expertise and experience in conducting key informant interviews and in survey design, deployment, and analysis.
- Demonstrated capacity to analyze and synthesize quantitative and qualitative data.
